

2015 PAYPAL BATTLEHACK DEVELOPER'S COMPETITION – WORLD FINALS OFFICIAL RULES

1. ELIGIBILITY: No Purchase Necessary. **The 2015 PayPal BattleHack Developer's Competition – World Finals** (the "World Finals") is open to members of the first place or first prize winning team of each of the fourteen 2015 PayPal BattleHack Developer's Competitions who are 18 years of age and older or who are the age of majority in their country of residence ("Eligible Participants"). Void in Puerto Rico and where prohibited. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses) and their respective household members, of PayPal, Inc. ("PayPal" or "Sponsor") or its parent company, affiliates, subsidiaries, divisions or advertising and promotion agencies are not eligible to enter. The World Finals are subject to, and you agree to be bound by, these official rules (these "Official Rules") and all applicable federal, state and local laws. Sponsor reserves the right to change or add to these Official rules by posting an updated version on <http://battlehack.org>. U.S. law governs the World Finals.

2. COMPETITION TIMING, TRAVEL RESTRICTIONS, ABSENT PARTICIPANTS AND SUBSTITUTIONS: The World Finals will take place in San Jose, CA on November 14-15, 2015.

The first place or first prize winning teams eligible to participate in the World Finals will receive the following:

- Roundtrip air transportation from a major airport nearest the traveler's residence to San Jose, CA for the World Finals;
- hotel accommodations during the World Finals;
- and transfers to and from such hotel to the World Finals.

The approximate retail value ("ARV") of this prize is \$1,700 USD. The actual value of the trip depends upon the city of departure, time of travel, any airfare fluctuations and on current market conditions at time of fulfillment. Any difference between the stated ARV and the actual value, if any, will not be awarded.

Each traveler must be able to travel on dates specified above by Sponsor or this prize will be forfeited and an alternate winner of the applicable PayPal BattleHack Developer's Competition may be selected. The trip is subject to air/hotel availability and confirmation of reservations; certain travel restrictions and blackout dates may apply. The trip may not be combined with any other offer. Airline and flight times will be selected by Sponsor at its sole discretion. One or more stopovers may be required on air transportation. Air transportation, if applicable, and hotel accommodations must be taken together and cannot be taken separately. All travel arrangements must be made through Sponsor's agent on a carrier of Sponsor's choice. Once trip dates have been booked, no change, extension or substitution of trip dates is permitted, except at Sponsor's sole discretion. Each traveler must confirm available travel dates and flight times selected by Sponsor at least three (3) weeks prior to travel dates. No extension or change of trip dates are permitted. Sponsor will not replace any lost or stolen tickets, travel vouchers, certificates or similar items once they are in traveler's possession. If the traveler resides within

100 miles of San Jose, CA, the air transportation portion of the prize will not be awarded and ground transportation will be substituted and no additional compensation will be provided. Each traveler must possess valid ID and is solely responsible for obtaining all necessary and required travel documents (passport, etc.) in order to travel. Sponsor, its affiliates, subsidiaries, divisions, advertising and promotion agencies, and Tenthwave Digital LLC shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels or other transportation companies or any other persons providing any of these services and accommodations to passengers including any results thereof such as changes in services or accommodations necessitated by same; and shall not be liable for any loss or damage to baggage. All airline tickets issued in conjunction with this prize are not eligible for frequent flyer miles. Prize components cannot be used in conjunction with any other promotion or offer, and no portion may be separated except at Sponsor's sole discretion. Prize conditions may be added or modified by companies providing those portions of the prize. The prize restrictions/conditions stated herein are not all-inclusive and may be subject to additional restrictions/conditions, which may be stated in the affidavit and release and/or prize travel documents. Costs for room and tax are based only on one room; meals, telephone calls, baggage fees and other incidentals are not included. **For clarity, if an eligible participant is unable to attend the World Finals for any reason, PayPal is not obligated to provide an alternative prize, and the absent participant forfeits his or her right to win any prize at the World Finals, even if the absent participant would have been a member of a winning team at the World Finals.** If such an eligible participant who is unable to attend the World Finals is a member of a team, Sponsor may, in its sole discretion, permit the team to designate a substitute participant for the World Finals; if Sponsor permits a substitute participant, the substitute participant would be eligible to win prizes at the World Finals.

3. HOW TO PARTICIPATE IN THE WORLD FINALS: You will need to provide Sponsor at the World Finals with the email address associated with your PayPal account, your name and mailing address. Prior to the start of developing and submitting an Entry, Sponsor will review specific procedures with the Eligible Participants.

To participate in the World Finals, **you must submit to the World Finals judges attending the event a unique application created on-site at the World Finals ("Application" or "Entry") using PayPal, Braintree or Venmo APIs.** You must present to the World Finals judges an original project of an Application during a time window defined at the World Finals. **Your Entry must be a working application in order to be eligible; prototypes are not acceptable. PayPal, Braintree or Venmo must be the sole payment method included in your application in order to be eligible.** All work on your Application must be performed during the time window defined at the World Finals. **You may not perform any work on your Application prior to the time window defined at the World Finals or your Entry will be disqualified at the sole discretion of Sponsor.** Only new Applications not previously submitted at the regional PayPal BattleHack Developer's Competitions will be considered by the judges. All components of each Entry must be submitted in accordance with these Official Rules. You may not submit more than one (1) Application at the World Finals, whether you are an individual entrant or part of a team. An Eligible Participant (or team) must be the sole owner of the Application submitted.

If you enter the World Finals as a member of a team, you understand and agree that, in order for a team to be eligible to participate, all of the members of the team must meet the eligibility criteria contained herein and agree to these Official Rules. By entering, you represent and warrant that you have obtained the appropriate agreement and/or approval by your team members. In addition, you understand and agree that if the team is selected to receive the Grand Prize, the prize amount will be divided equally and dispersed to all team members (maximum of 4 team members). Winning team members will receive their shares of the prize money as a payment to their respective PayPal accounts. If the team is selected to receive a First or Second Place Prize, each team member will be awarded the merchandise prize, up to a maximum of four (4) people on a team. If a team member is unable to participate in the World Finals, a team may choose a substitute team member to participate in the World Finals, providing that person meets the eligibility requirements as stated above in these Official Rules. If one team member does not comply with these Official Rules or is disqualified, the entire team will be disqualified.

The Entry must be in keeping with Sponsor's image, and may not be offensive, nor can it defame, or invade upon the publicity rights or privacy of any person or otherwise infringe upon any person or entity's intellectual property, personal or proprietary rights, as determined by Sponsor and the judges in their sole discretion. Each entrant must either (i) be the sole and exclusive owner of all rights (including, without limitation, all intellectual property rights) in and to all content and elements incorporated into or used in the Entry; or (ii) have the express written permission to use such content and elements from the owner(s) of the rights to such content and elements. Any entrant whose Entry includes content or elements not owned by the entrant must be able to provide written legal releases (in a form that is satisfactory to Sponsor and the judges) that permit the entrant to use and exploit such content and elements in the manner used and exploited and that permit Sponsor's right to use and exploit the content and materials in accordance with these Official Rules ("IP Releases") before eligible to be declared a winner.

SPONSOR RESERVES THE RIGHT, AT ITS SOLE DISCRETION, TO DISQUALIFY ANY ENTRY THAT SPONSOR FEELS IS INAPPROPRIATE, OBJECTIONABLE AND/OR INCONSISTENT WITH THE POSITIVE IMAGE AND/OR GOODWILL IT WISHES TO PROMOTE IN THESE WORLD FINALS.

ALL ELIGIBLE PARTICIPANTS ACKNOWLEDGE AND AGREE THAT ALL ENTRY MATERIALS SUBMITTED IN CONNECTION WITH THE WORLD FINALS ARE SUBMITTED ON A NON-CONFIDENTIAL BASIS AND MAY BE USED BY SPONSOR, ITS AGENTS AND SUBSIDIARIES, FOR ADVERTISING AND PROMOTIONAL PURPOSES AS DESCRIBED IN SECTION 8 BELOW.

Entries that are mechanically reproduced, copied, illegible, incomplete or inaccurate are void. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. If a dispute results as to the identity of an entrant, it will be determined that the Entry was submitted by the natural person assigned to the Developer ID number. Entrants

may use the PayPal name in the Application and description in a descriptive manner to describe the PayPal Services, PayPal websites and activities related to the PayPal websites. Sponsor grants Eligible Participants a limited, non-exclusive license to use the PayPal logo or intellectual property owned by PayPal in the Application and description for purposes of the World Finals only. In the event an Eligible Participant wishes to use this Application for any other purpose, he/she/they must follow standard procedures for using PayPal IP (including logos). Incomplete Entries or Entries not complying with these Official Rules are subject to disqualification. Sponsor is not responsible for late, lost, incomplete, illegible, damaged, or misdirected Entries. Sponsor's decisions are final on all matters relating to the World Finals. Sponsor reserves all rights, including the right to edit, publish, use, adapt, modify, or dispose of any application/description, proper names, likenesses, and photographs for advertising and promotional purposes in all media (including, but not limited to, the internet) without additional compensation, except where prohibited by law. If an entrant changes his/her telephone number, email address, and/or street address after he/she enters the World Finals, it is his/her sole responsibility to notify Sponsor by email at developer@paypal.com to be received by the end of the Promotion Period.

4. DETERMINATION OF WINNERS: One (1) Grand Prize winner, one (1) Second Place winner and one (1) Third Place winner will be determined from among all Eligible Participants. All eligible Entries will be judged by a panel of expert judges (internal and/or external to PayPal) selected by Sponsor in its sole discretion, and one (1) Grand Prize winner, one (1) Second Place winner and one (1) Third Place winner will be determined from among all valid Entries submitted for the World Finals. Each team of Eligible Participants (or individual Eligible Participant, if not on a team) will have up to five (5) minutes to present its Entry to the panel of judges and up to five (5) minutes to answer questions from the judges. To be eligible for the judges' consideration, the Entry must first pass code inspection conducted by a panel of expert judges from PayPal ("Code Review Council"), who will review and inspect code for: a) Completeness and integration of PayPal, Braintree or Venmo, and b) completeness of product. Judging will be based on the following criteria: (i) the quality of the idea – 33%, (ii) its implementation, including but not limited to the Code Review Council's report, technology used, level of innovation and originality of code – 33%, and (iii) execution, as well as the overall user experience – 34%. The top-scoring Entry will be declared a potential Grand Prize winner, the Entry with the second highest score will be declared the potential Second Place winner and the Entry with the third highest score will be declared the potential Third Place winner, subject to verification and compliance with these Official Rules. In the event of a tie, the Entries involved in the tie will be reviewed by an additional judge who will serve as a tiebreaker and who will evaluate Entries according to the criteria listed above. Decision of judges is final and binding on all matters relating to the World Finals. Winners will be determined at the end of the World Finals.

5. WINNER NOTIFICATION: Potential Grand Prize winner, potential First Place winner and potential Second Place winner will be notified immediately following the World Finals, at the event, and/or by email, telephone and/or U.S. mail using the contact information provided at the time of entry. If PayPal or its authorized agents are not able to contact the potential

winners by midnight Pacific Time 14 calendar days after the first attempted notification, alternative winners may be chosen by the judges and the original winners' entitlement will lapse. Potential winners may be required to provide copies of Intellectual Property (IP) Releases (if applicable) and will be required to sign an affidavit of eligibility and liability release and, where legal, a publicity release and a federal and state tax release and return same, properly executed, within 48 hours via fax or email (or within five (5) days via postal mail) of issuance of notification. Failure to return any or all documents fully-executed within the specified time period, or if any notification is returned as undeliverable, will result in disqualification and a runner-up may be selected. PayPal may ask for proof from the winners to verify their identity. PayPal may also ask the winners to provide proof of their age and/or country of residence.

6. PRIZES: One (1) Grand Prize: \$100,000 USD paid in the form of a payment to the winner's PayPal account or if a team is the winner, divided evenly among up to four (4) team members in the form of a payment to each team member's PayPal account associated with the email address provided. If the email address provided is not associated with a winner's PayPal account, it must be associated with a winner's PayPal account within 7 days from time of prize notification. A prize will not be awarded to a winner with a locked, closed or restricted account. The total ARV of the Grand Prize is \$100,000 USD. Each potential team member winner must have a PayPal account in good standing in order to receive a prize. One (1) Second Place Prize: winner or each team member if team is winner (maximum of four (4) potential winners per team) will receive a Tech Toys Bundle which may include: Nest Thermostat (3rd generation model); On Hub; Project Tango Tablet Development Kit; Philips Hue Light Starter Kit; August Smart Lock; and Canary All-in-One Security. The approximate ARV of the Second Place Prize is \$1,650 (USD)/each. One (1) Third Place Prize: winner or each team member if team is winner (maximum of four (4) potential winners per team) will receive an Oculus Rift Development Kit 2 with Steel Series H Wireless Gaming Headset. The approximate ARV of the Third Place Prize is \$650 (USD)/each. Total ARV of all prizes: up to \$109,200. All guarantees and warranties on merchandise prizes are subject to the manufacturers' terms and conditions, and winners agree to look solely to such manufacturers for any such warranty or guarantee claim.

Any other costs and expenses not specifically stated within these Official Rules and all taxes due on the prizes or other benefits received, if any, are the sole responsibility of the participants and winners. Sponsor has no liability for any taxes that you may owe as a result of participating in the World Finals or receiving a prize. The prizes may not be transferred or substituted, except at Sponsor's sole discretion. Specifics of a prize are in Sponsor's sole discretion. Sponsor reserves the right, in its sole discretion, to award a prize of equal or greater value. Allow 4-6 weeks for receipt of a prize.

7. CONDITIONS OF PARTICIPATION: Sponsor will collect information from the entrant for the purpose of the World Finals and may attempt to contact entrant regarding the World Finals and/or the Application. By accepting a prize, each winner consents to the use of his/her name, image, likeness, photograph, voice and biographical material and entry submission for

advertising, publicity and promotional purposes by Sponsor and any party designated by Sponsor in any and all media now or hereafter known including but not limited to, any online announcements, or for sharing this information with the press for viewing, whether TV or print, throughout the world in perpetuity, without additional compensation, notification or permission, except where prohibited by law. By participating, entrants agree to be bound by these Official Rules including all eligibility requirements. Entrants agree to abide by the terms of these Official Rules and the decisions of the judges, which are final, and waive any right to claim ambiguity in these Official Rules. Entrants agree that any and all disputes shall be governed by the laws of the State of California.

8. GRANT OF LICENSE: By submitting an Entry in the World Finals, entrant agrees that, he/she is granting to PayPal and its designees an irrevocable, perpetual, royalty-free, non-exclusive license to use his/her name, picture, likeness, voice, biography and Entry (or any part of them) in any way, form or manner that PayPal wants for advertising, promotional or publicity purposes, including but not limited to promotional videos, press releases, tweets and other social media posts. "Non-exclusive" means that you can continue to use your Entry in any way, including allowing others to use it. PayPal cannot guarantee that your Entry will be used by PayPal and reserves the right to edit or refuse to use your Entry. PayPal may use your Entry without attributing it to you personally and, to the extent permitted under applicable law, you waive your moral rights (under UK copyright law this is your right to be identified as the author of the Entry) in respect of your Entry when used by PayPal.

All Entries shall remain the property of entrants. Each entrant agrees that Sponsor may, without any limitation or further compensation, use his or her name, voice and/or likeness in any and all media for the purpose of advertising and promoting the PayPal websites, the World Finals, or any other promotion, sponsored by Sponsor. Neither entrants nor winners shall be entitled to receive any compensation or credit for use of Entries, other than that disclosed in these Official Rules.

By submitting an Entry, entrant acknowledges and agrees that Sponsor may obtain many entries in connection with this and/or other competitions staged and/or promoted by Sponsor, and that such entries may be similar or identical in theme, idea, format or other respects to other entries submitted in connection with the World Finals and/or other competitions sponsored by Sponsor or submitted for other reasons or other materials developed by Sponsor. Entrant waives any and all claims entrant may have had, may have, and/or may have in the future, that any Entry and/or other works accepted, reviewed and/or used by the entrant may be similar to his/her Entry, or that any compensation is due to entrant in connection with such entry or other works used by Sponsor. By submitting an Entry, entrant hereby grants permission for the Entry to be posted on a PayPal website or other websites. Entrant agrees that Sponsor is not responsible for any unauthorized use of Entries by third parties. Sponsor does not guarantee the posting of any Entry.

9. REPRESENTATIONS AND WARRANTIES: Entrant represents and warrants the following:
1) that he/she is the original author (or represents and warrants that the owner of such rights has expressly granted any and all necessary rights to the entrant) of any and all Entry materials

posted, uploaded, or otherwise sent to PayPal (modifying, enhancing or altering a third party's pre-existing work does not qualify as entrant's original creation); 2) the Entry will not infringe any third party's copyright, patent, trademark, trade secret or other proprietary rights or rights of publicity or privacy (entrants are prohibited from posting, uploading, or otherwise sending to PayPal any Entry material that infringes on any copyright, trademark or proprietary rights of another (including publicity and privacy rights)); 3) that the submission is not the subject of any actual or threatened litigation or claim; 4) that the Entry material is not obscene, offensive, libelous, pornographic, threatening or abusive, does not contain illegal content, is not otherwise objectionable, would not constitute or encourage a criminal offense, and would not otherwise give rise to liability or violate any law; 5) that publication of the Entry via various media, including web posting, will not infringe on the rights of any third party. If PayPal has reason to believe your Entry is not your own work, then PayPal may invalidate your Entry into the World Finals. LIMITATION OF LIABILITY: ENTRANTS HEREBY AGREE TO RELEASE, INDEMNIFY AND HOLD HARMLESS SPONSOR, ITS PARENT COMPANY, AFFILIATES, SUBSIDIARIES, DIVISIONS, ADVERTISING AND PROMOTION AGENCIES AND THEIR RESPECTIVE EMPLOYEES, OFFICERS, DIRECTORS, AGENTS, REPRESENTATIVES AND SHAREHOLDERS (COLLECTIVELY, THE "RELEASEES") FROM ANY CLAIMS, ACTIONS, INJURY, LOSS OR DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO, PERSONAL INJURY OR DEATH, RESULTING FROM PARTICIPATING IN THE WORLD FINALS OR ANY OTHER COMPETITION OR FROM THE ACCEPTANCE, POSSESSION, OR USE OR MISUSE OF ANY PRIZE AWARDED OR PARTICIPATION IN ANY PRIZE-RELATED ACTIVITY. THIS LIMITATION OF LIABILITY IS A COMPREHENSIVE LIMITATION OF LIABILITY THAT APPLIES TO ALL DAMAGES OF ANY KIND, INCLUDING (WITHOUT LIMITATION) COMPENSATORY, DIRECT, INDIRECT, OR CONSEQUENTIAL DAMAGES; LOSS OF DATA, INCOME, OR PROFIT; LOSS OR DAMAGE TO PROPERTY; AND CLAIMS OF THIRD PARTIES. PARTICIPANTS AGREE THAT RELEASEES HAVE NOT MADE NOR ARE IN ANY MANNER RESPONSIBLE OR LIABLE FOR ANY WARRANTY, REPRESENTATION, OR GUARANTEE, STATUTORY, EXPRESS OR IMPLIED (INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, TITLE, AND FITNESS FOR A PARTICULAR PURPOSE), IN FACT OR IN LAW, RELATIVE TO THE WORLD FINALS OR THE PRIZES AWARDED. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, RELEASEES DO NOT MAKE ANY EXPRESS OR IMPLIED WARRANTIES OR REPRESENTATIONS WITH RESPECT TO ANY PAYPAL WEBSITE AND RELEASEES SHALL NOT BE LIABLE FOR THE CONSEQUENCES OF ANY INTERRUPTIONS OR ERRORS RELATED THERETO. Entry materials that have been tampered with or altered are void. Sponsor reserves the right, in its sole discretion, to cancel or suspend part or all of the World Finals (or disqualify any Entry) at any time without notice, if in the judges' opinion there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the World Finals, or if any virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or integrity and proper play of the World Finals or for any other reason in its sole discretion. In such event, Sponsor may void any Entries it suspects are at issue and award the prize from among all non-suspect eligible entries.

CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE THE PAYPAL WEBSITES OR ANY ONLINE SERVICE RELATED TO THE WORLD FINALS OR TO UNDERMINE THE LEGITIMATE OPERATION OF THE WORLD FINALS MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEY'S FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING CRIMINAL PROSECUTION. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of such term or any other provision. Sponsor reserves the right to disqualify any entrant who violates the rules or interferes with the World Finals in any manner. Any attempt by an individual to access any website associated with the World Finals via a bot script or other brute force attack or any other unauthorized means will result in the IP address becoming ineligible. Use of automated entry devices or programs is prohibited.

Without limiting the generality of the foregoing, each participant agrees to release and hold harmless the Releasees from and against any and all claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement or any other intellectual property related cause of action that relate in any way to the Entry.

Sponsor reserves the right, in its sole and absolute discretion, to cancel, amend or suspend the World Finals or to amend these Official Rules, without notice or obligation, for any reason.

11. DISPUTES: Except where prohibited, all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the participants and Sponsor in connection with the World Finals, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California, or any other

jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.

In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any event-related materials, including, but not limited to: the PayPal websites and/or point of sale, television, print or online advertising; the terms and conditions of these Official Rules shall prevail, govern and control.

Sponsor reserves the right, in its sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Official Rules, to the extent necessary, for purposes of verifying compliance by any entrant or Entry with these Official Rules, or as a result of technical problems, or in light of any other circumstances which, in the opinion of Sponsor, in its sole and absolute discretion, affect the proper administration of the World Finals as contemplated in these Official Rules.

With respect to the World Finals, these Official Rules will control in the event of any conflict between these Official Rules and any terms and conditions or rules applicable to any of the other PayPal BattleHack Developer's Competitions.
